# 0% INTEREST TAX CREDIT LOAN

## MAKE A DONATION!

The State of Arizona allows taxpayers to make monetary contributions to public and private schools. Taxpayers who make a qualified contribution will receive a credit on their state tax return for the donation amount.

## DON'T HAVE THE MONEY?

Because you must make your qualified donation before the end of the year, Tempe Schools Credit Union will loan you the money you need to make a donation to your school of choice. You borrow the money—at 0% interest—to make the donation. When you receive your state tax refund check, simply pay us back. Your tax credit loan is made at 0% interest, provided you pay back the loan before May 31, 2008.

## PUBLIC SCHOOL DONATION GUIDELINES

Individuals and head of household are limited to a credit of \$200.00. Married couples filing jointly are limited to a credit of \$400.00. The school will provide a receipt to the donor that includes the school name, school district number, taxpayer name, taxpayer Social Security number, amount paid, date paid and a description of the activity for which the donation was made.

## PRIVATE SCHOOL DONATION GUIDELINES

Individuals or head of household are limited to a credit of \$500.00. Married couples filing jointly are limited to a credit of \$1,000.00. The donor may not designate that his/her donation directly benefit his/her dependent. The school will provide a receipt to the donor that includes the school name, school district number, taxpayer name, taxpayer Social Security number, amount paid, date paid and a description of the activity for which the donation was made.

## PROMISSORY NOTE

The maker agrees to pay Tempe Schools Credit Union, or any person or agent it designates, ("payee") the amount written on the front of the note under the terms and conditions listed below:

- 1. SINGLE INSTALLMENT.** Maker agrees to pay the amount due under this note by May 31, 2008, without interest.
- 2. PREPAYMENT.** The principal due under this note may be prepaid at any time without penalty.
- 3. SECURITY.** This note is unsecured.
- 4. DEFAULT.** Should maker fail to make the payment due under this note by May 31, 2008, then the principal amount of this note shall earn interest at the annual percentage rate of eighteen percent (18%) per year from the date of the loan until paid in full.
- 5. WAIVERS.** The maker of the note waives presentment, notice of dishonor or protest for the nonpayment of this note.
- 6. ATTORNEY'S FEES.** Should the payee or maker of this note file a legal action to enforce the terms of this note, then the prevailing party in such action, in addition to any other remedy provided by law shall be entitled to an award of attorney's fees and expenses. Such an award shall be made by the trial court, sitting without a jury, at the conclusion of all proceedings in the case.
- 7. WAIVER OR TRIAL BY JURY.** The payee and maker of this note specifically waive their right to a trial by jury in and legal action instituted to enforce or interpret this note.
